*(Each customer is limited to one dehumidifier rebate per calendar year.)*
- Application must be submitted within 45 days from purchase date or by January 15 of the following calendar year, whichever comes first.

Incomplete information will delay or disqualify your rebate. All rebate requests must be submitted within 45 days from purchase date or by January 15 of the following calendar year, whichever comes first. ## Did You Know?

ENERGY STAR certified dehumidifier models have more efficient refrigeration coils, compressors and fans than conventional models, which means they use less energy to remove moisture. An ENERGY STAR certified dehumidifier removes the same amount of moisture as a similarly sized conventional unit, but uses 15% less energy.
