- You purchased\* a current ENERGY STAR<sup>®</sup> certified refrigerator between 1/1/19 - 12/31/19.  
\*All qualifying models must be purchased at a participating retailer.
- You have not submitted another Appalachian Power refrigerator rebate in 2019.
- Application must be submitted within 45 days from purchase date or by January 15, 2020, whichever comes first.
- Refrigerator must be >7.75 cubic feet.

## Did You Know?

Refrigerators that have earned the ENERGY STAR are about 9 percent more energy efficient than models that meet the minimum federal energy efficiency standard.

By properly recycling your old refrigerator and replacing it with a new ENERGY STAR certified refrigerator, you can save more than \$270 over the next five years!

Refrigerators over ten years old could be costing you about \$110 per year to run. If you need a second refrigerator year round, replace the old one with a new ENERGY STAR certified unit and save more than \$50 a year in operating costs.

Incomplete information will delay or disqualify your rebate. All rebate requests must be postmarked no later than January 15, 2020. Please allow up to six weeks for rebate processing.
